Enclosed is a tentative Order to rescind Cease and Desist Order No. R5-2004-0111 and adopt a new Cease and Desist Order. To be given full consideration, any comments or recommendations you may have concerning the enclosed documents must be submitted in writing to the Regional Water Quality Control Board (Regional Water Board) office by 5:00 p.m. on **15 November 2009**. Written materials submitted after 5:00 p.m. on **15 November 2009** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. Please note that the tentative documents will receive internal legal and management review during the public comment period

A Public Hearing has been scheduled for the Regional Water Board to consider adoption of the tentative Order at its 9, 10, and 11 December 2009 Board Meeting. The Notice of Public Hearing and a copy of a Proof of Posting form are also enclosed. By **16 October 2009** post one (1) copy of the Notice at:

- The nearest city hall or county courthouse
- The post office nearest to the Facility (if allowed)
- At the public offices of the Bella Vista Water District.

Proof of posting, using the enclosed form, shall be filed with this office by **21 October 2009**.
