TENTATIVE WASTE DISCHARGE REQUIREMENTS (NPDES NO. CA0079731) FOR CITY OF REDDING CLEAR CREEK WASTEWATER TREATMENT PLANT SHASTA COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed are revised tentative Waste Discharge Requirements (NPDES No. CA0079731) for the City of Redding, Clear Creek Wastewater Treatment Plant. This revised tentative Order includes revisions made to the previous May 2010 tentative Order. The revisions are shown in underline/strikeout format. Only comments or recommendations on the revisions will be accepted. To be given full consideration, any comments or recommendations you may have concerning the revisions to the tentative Order must be submitted in writing to the Regional Water Quality Control Board (Central Valley Water Board) office by **5:00 pm on 27 August 2010**. Written materials submitted after this date and time will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. Please note that the tentative documents will receive internal legal and management review during the public comment period.

A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of the tentative Order at its 22/23/24 September 2010 Board Meeting. The Notice of Public Hearing (4 copies) and a copy of a Proof of Posting form are also enclosed. **By 28 July 2010** post one (1) copy of the Notice of Public Hearing at:

- The entrance to the facility;
- The nearest city hall or county courthouse; and
- The post office nearest to the Facility (if allowed).

Proof of posting, using the enclosed form, shall be filed with this office by 30 July 2010. To conserve resources, this letter transmits a paper copy of the tentative documents to the discharger only.
