**NOTICE OF PUBLIC HEARING**  
concerning

**WASTE DISCHARGE REQUIREMENTS  
FOR  
VON BARGEN RANCH SEPTAGE DISPOSAL AREA  
GLENN COUNTY**

Scott and Sandy Von Barga (Discharger) own and operate the Von Barga Septage Ranch Septage Disposal Area, located approximately 2 miles southeast of Artois in Glenn County. The Discharger may be contacted by mail at P.O. Box 126, Artois, CA 95913. Septage haulers throughout Glenn County have transported domestic septage / wastewater to the 40-acre disposal area since at least 1975 and possibly since 1950. Historical disposal practices have consisted of lime stabilization to raise the pH to a minimum of 12.0 for one half hour for pathogen and vector prevention, followed by land application. Domestic septage is spread by septic trucks, which drive to the south end of the disposal area, where they turn around and open their discharge valve, and drive north while the septage is released. Current practices also include planting oat crops on half of the land application area each year during the fall. The oats are harvested during the spring and used as animal feed. The area where septage is land applied is mowed and tilled with a disc about once every other month. The other half of the land that is planted is rotated each year.

The Discharger is expected to be able to immediately comply with the tentative WDR permit, if adopted. The Central Valley Water Quality Control Board (Central Valley Water Board) considered adopting the tentative Waste Discharge Requirements at its 10 June 2011 Board meeting, however, the Board continued the adoption of the proposed Order. A public hearing concerning this matter will be held during the Central Valley Water Board meeting that is scheduled for:

The tentative Waste Discharge Requirements were issued on 5 April 2011, and the comment period ended on 5 May 2011.
