**RENEWAL OF WASTE DISCHARGE REQUIREMENTS
(NPDES NO. CA0078671)
AND TIME SCHEDULE ORDER**

EL DORADO COUNTY**

El Dorado Irrigation District is the owner and operator of the El Dorado Hills Wastewater Treatment Plant (Facility), located at 4625 Latrobe Road in El Dorado Hills. The Facility provides sewerage service for the community of El Dorado Hills. Tertiary treated wastewater from the Facility is discharged to Carson Creek, a tributary to Deer Creek and the Cosumnes River.

Discharges from the Facility are currently regulated by Order R5-2007-0069, an NPDES permit issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 22 June 2007. The proposed NPDES permit renewal includes effluent limitations for bis (2-ethylhexyl) phthalate and four persistent chlorinated hydrocarbon pesticides to which the Discharger cannot immediately comply. Existing Time Schedule Order (TSO) R5-2010-0030-01 includes a compliance schedule for bis (2-ethylhexyl) phthalate and all persistent chlorinated hydrocarbon pesticides. A new-TSO is proposed allowing the same compliance schedule for compliance with final effluent limitations for bis (2-ethylhexyl) phthalate and the four persistent chlorinated hydrocarbon pesticides required in the proposed permit.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 7 December 2012**. The request must

explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m.** on **7 December 2012**. Written evidence or comments submitted after **5:00 p.m.** on **7 December 2012** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
