NOTICE OF PUBLIC HEARING

concerning

WASTE DISCHARGE REQUIREMENTS

FOR

OLSON MEAT COMPANY, INC.

MEAT PACKING FACILITY

GLENN COUNTY

Olson Meat Company Inc. (hereafter Discharger) Olson Meat Packing Facility, located in Orland, Glenn County, discharges wastewater to an onsite land application area. The Discharger commenced operation at the Facility in 2002 for pork production. On commencing operation, the Discharger implemented several mitigation measures including the use of wastewater for irrigation, and eleven (11) pond wastewater settling/treatment system. This Facility has not previously been regulated by the Central Valley Water Board. The purpose of this Order is to prescribe requirements that are protective of the waters of the State and reflect the Discharger's existing discharge and treatment system. About 10,630 gallons of process wastewater is generated by the facility during daily operations. The Discharger operates 258 days a year, for an annual discharge of approximately 2.8 million gallons to a land application area.

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider adopting Waste Discharge Requirements for the Facility. A public hearing to address this matter will be held during the Central Valley Water Board meeting which is scheduled for:

The designated parties for this hearing are as follows:

- Olson Meat Company Inc.

Designated parties but not interested persons will have these rights: to call and examine witnesses; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Central Valley Water Board staff will prepare the administrative record, and may present evidence, make an oral presentation and cross-examine opposing witnesses.

Interested persons may not cross examine witnesses, and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **26 April 2013**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

The tentative Waste Discharge Requirements and Monitoring and Reporting Program were issued on **27 March 2013**. Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on 26 April 2013**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair. Both designated parties and interested persons may be asked to respond to clarifying questions from Board members, counsel staff or others, at the discretion of the Board.
