NOTICE OF PUBLIC HEARING

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS
(NPDES PERMIT NO. CA0082660)
AND
RESOLUTION GRANTING THERMAL PLAN EXCEPTION**

**FOR
CITY OF BRENTWOOD
WASTEWATER TREATMENT PLANT
CONTRA COSTA COUNTY**

The City of Brentwood (Discharger) owns and operates the City of Brentwood Wastewater Treatment Plant (Facility), serving a population of approximately 52,000. The United States Environmental Protection Agency and the Central Valley Regional Water Quality Control Board (Central Valley Water Board) have classified this discharge as a major discharge. Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5 2008-0006-01, permitting an average dry weather discharge flow of 5 million gallons per day of tertiary treated municipal wastewater to Marsh Creek, a water of the United States, within the legal boundary of the Sacramento-San Joaquin Delta (Delta).

The proposed NPDES permit renewal includes new or revised effluent limits for bis (2-ethylhexyl) phthalate, chloride, dibromochloromethane, mercury, methylmercury, chlorpyrifos, and diazinon, and removes the effluent limits for aluminum (total recoverable), iron (total recoverable), oil and grease, and electrical conductivity. The proposed NPDES permit renewal also includes revised effluent and receiving water limitations for temperature based on the proposed resolution granting a Thermal Plan exception.

The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.
