Per our telephone conversation of yesterday, A Greener Globe, Daniel G. Sheehan received and signed for the State Board Order of October 15, 1999, on October 19, 1999.

We hand delivered to your office on November 19, 1999 our request for review of that certain Order No.99-724, without realizing that October had 31 days we delivered the request for review on the 31st day.

This oversight on our part is Excusable, Justifiable, Allowable and Defensible. We were/are without counsel, because we have no funds for legal advice. Such one day delay is Justifiable, as all of those items contained in that Order No. 99-724 which we all consider critical, are in-fact completed. The only remaining item is a monetary one.
