ADMINISTRATIVE CIVIL LIABILITY COMPLAINT NO. R6T-2016-0008 FOR ARAMARK – EL DORADO COUNTY


On March 8, 2016, the Lahontan Water Board Prosecution Team issued Revised Administrative Civil Liability Complaint No. R6T-2016-0008 (Complaint) to Aramark Sports and Entertainment Services, LLC and Travel Systems, LLC (Aramark).

The Complaint proposed that the Regional Water Quality Control Board, Lahontan Region (Water Board) assess an administrative civil liability against the Discharger in the amount of \$4,683.

The complaint provided an opportunity for Aramark to waive its right to a hearing and agree to pay the assessed penalty of \$4,683 for the alleged violations. On March 25, 2016 Aramark took such action by submitting a signed copy of the Waiver of Hearing Form, and providing payment of the full penalty.

This action constituted a proposed settlement that is subject to a 30-day public comment period pursuant Water Code section 13385 and the State Water Resources Control Board's Enforcement Policy. On April 6, 2016, the Administrative Civil Liability and signed Waiver of Hearing Form was sent to interested parties along with a Notice of Public Comment period. On May 6, 2016, the public comment period closed, with no comments received. This matter is considered closed and final.
