Please allow a reasonable amount of time for the Water Board staff to review your request and make a determination.

Grading, filling, and clearing of vegetation that disturbs soil, and all other disturbances of soil between <u>October 15 of any year and May 1 of the following year in the Lake Tahoe Hydrologic Unit is prohibited</u>.

All disturbed areas not subject to a variance granted by Water Board staff prior to October 15 must be winterized by October 15 in a manner that will remain effective until May 1. Where the Discharger shows that granting a variance would not cause or contribute to the degradation of water quality, an exception to the dates stated above may be granted in writing by the Executive Officer. Dischargers are advised to maintain compliance with all

requirements and complete and provide this form to the California Regional Water Quality Control Board, Lahontan Region (Water Board) to ensure that all necessary information is provided to Water Board staff in adequate time for consideration of a variance.

I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to ensure that qualified personnel properly gather and evaluate the information submitted. I certify that my project site will be fully winterized in accordance with waste discharge requirements during the prohibition period in the event that a variance is not granted.

"Winterized" means implementing erosion and/or sediment controls that will minimize or prevent the discharge of earthen materials from the site and the controls will remain effective throughout the rainy/snow season without requiring maintenance. In general, this requires stabilizing bare disturbed soils with mulch, erosion protection blankets, or other suitable materials, and installing perimeter sediment controls such as fiber logs or other similar materials that will remain effective during significant rain and snow events.

To the best of my knowledge and belief, including information gathered from the project manager, the information submitted is, true, accurate, and complete. I am aware that there are significant penalties for submitting false information, including the possibility of fine and imprisonment for knowing violations.
