The following is a request for future and present residents or property owners of Hinkley, California.

One of the primary reasons for people to aquire and maintain rural or county properties in San Bernardino County, California is the use and/or ownership of individual water wells. Because of this fact I insist that people and properties in Hinkley California contaminated with Chromium 6 or any other substance or chemical product or by-product of the PG&E (Pacific Gas and Electric) business or clean-up be provided large pressurized tanks (1000, 5000, 10,000 gallon etc. according to needs) and clean water. Water could be provided weekly or bi-monthly, or provided when residents and/or property owners summon.

PG&E themselves could establish a schedule and system of checking tank levels and providing clean water. Usage of water would be

restricted to use on that property provided for unless given permission by PG&E and/or the Lahontan Region water Board, or because of usage by emergency services. I request this option of clean water provision by PG&E to Hinkley property owners and residents be required so as to maintain and preserve the quality of life of the people.

Water provided must meet the existing or maximum potential use of the property owners and/or residents. Thus, if a property or residents require water for a family large or small and/or water for a crop or garden and/or water for basic recreational needs and/or water for domestic animals including dogs, cats, horses, cows etc. and/or water for assisting a business and/or water for numerous trees or shrubs etc., then the necessary clean water should be provided as to maintain and preserve the quality of life of the residents and property owners whose land is contaminated as result of PG&E business or clean-up activities.

Residents and property owners of Hinkley, California must be informed as to where and when clean replacement water comes. The exact sources must be identified. This water must be tested on a regular basis, and must be tested immediately if the source changes. This water must come from outside contaminated Hinkley area and must come further than 20 miles from contaminated Hinkley lands.
