WASTE DISCHARGE REQUIREMENTS
FOR
RESCISSION OF WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:

1. The below-listed Board Orders contain waste discharge requirements for waste discharge facilities that are discharging less than 15,000 gallons-per-day, or are no longer in use.

4. The Board at a public hearing heard and considered all comments pertaining to the proposed rescinding of the below-listed Orders.


IT IS HEREBY ORDERED, the following Orders containing waste discharge requirements are rescinded:
