

RESOLUTION NO. R7-2008-0007
EXPRESSING APPRECIATION TO NANCY WRIGHT

- WHEREAS, Nancy Wright ably served as a member of the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Board), during the period of 2000 through 2007, served as Vice-Chair from February 2004 through March 2006, and served as Chair from May 2006 through November 2007; and
- WHEREAS, Nancy Wright brought to the Regional Board considerable enthusiasm and dedication on water quality matters; and
- WHEREAS, Nancy Wright played a key role in addressing New River pollution from Mexico, including supporting adoption of a Total Maximum Daily Load to address bacteria in the New River at the Border with Mexico, participating in Bi-national Border tours of the New River in Mexicali, Mexico, and ensuring the new wastewater treatment plant for Mexicali became a reality in 2006, which eliminated Mexicali's discharge of approximately 15 million gallons per day of raw sewage into the New River; and
- WHEREAS, Nancy Wright represented the Regional Board on the State's Salton Sea Ecosystem Restoration Advisory Committee from 2004 to 2007; and thanks to her leadership and vision there are substantial water quality improvements in the Regional Board's priority watershed, the Salton Sea Transboundary Watershed; and
- WHEREAS, Nancy Wright also participated in the Citizens for the Colorado River Citizens Forum to exchange information and make representations regarding Colorado River water quality and New River pollution from Mexico; and
- WHEREAS, Nancy Wright, during her tenure on this Regional Board, will be remembered as an active and supportive member and as a very affable person to work with; now therefore be it
- RESOLVED, That the Members of the California Regional Water Quality Control Board, Colorado River Basin Region, express their great and sincere appreciation to Nancy Wright for her outstanding service, participation, and friendship during her tenure as a Board Member; Vice-Chair, and Chair; and be it further
- RESOLVED, That the members of this Regional Board wish Nancy Wright the best of health and happiness in the future; and be it further
- RESOLVED, That the members of this Regional Board extend a warm welcome to Nancy Wright to attend meetings of this Board whenever she may wish to do so; and be it further


