This order renews waste discharge requirements for the discharge of urban storm water from areas of San Bernardino County within the Santa Ana Region. This item will be discussed at a public workshop during the July 10, 2009 Board meeting.

While the primary purpose of the July 10th workshop will be to present the proposed order to the Board, time will be made available for public comments. For the accuracy of the record, all comments should also be submitted in writing. All comments **received prior to August 10, 2009** will be considered during formulation of the next draft of this tentative order. We will respond to all comments either in writing or during subsequent workshops and/or public hearings. This item will be scheduled for a public hearing at a later date, and all interested parties will be notified.


