ERRATA SHEET ITEM NO. 5 AUGUST 8, 2007

1. Delete Finding No. 1 and replace with the following:

"WASTE DISCHARGE REQUIREMENTS. Except as contradicted or superceded by the findings and directives set forth in this Addendum, (Addendum No. 6) all of the previous findings and directives of Order No. 97-11, General Waste Discharge Requirements for Post-Closure Maintenance of Inactive Nonhazardous Waste Landfills Within the San Diego Region remain in full force and effect."

2. Delete Finding No. 2 and replace with the following:

"WASTE DISCHARGE: Between 1963 and 1972 the County of San Diego owned and operated the Alpine II Burn Dump (hereinafter Site) located at 9715, 9725 and 9727 Chocolate Summit Drive, Alpine, CA. The County discharged household rubbish, tree trimmings, non-combustibles and conducted waste burning operations at the Site."

3. Delete Finding No. 3 and replace with the following:

"PERSON RESPONSIBLE: The former Alpine II Burn Dump is currently located on three different parcels which were formerly leased by the County of San Diego. Two of these parcels (9715 Chocolate Summit Drive, APN 402-350-38 and 9727 Chocolate Summit Drive, APN 402-350-40) were subsequently developed with single-family homes; the remaining parcel (9725 Chocolate Summit Drive, APN 402-350-60) is currently undeveloped and owned by the County of San Diego. As a current property owner and the former operator of the Alpine II Burn Dump, the County of San Diego is identified as the "Discharger" responsible for the management of wastes and waste related constituents discharged at the Alpine II Burn Dump."

4. Delete Finding No. 5 and replace with the following:

"WATER QUALITY CONTROL PLAN. The Water Quality Control Plan Report, San Diego Basin (9), (hereinafter Basin Plan), was adopted by this Regional Board on September 8, 1994, and subsequently approved by the State Water Resources Control Board (State Board) on December 13, 1994. Subsequent revisions to the Basin Plan have also been adopted by the Regional Board and approved by the State Board. The Alpine II Burn Dump is located in the El Capitan Hydrologic Area (7.30). The Basin Plan designates beneficial uses; narrative and numerical water

quality objectives; and waste discharge prohibitions that are applicable to the discharges regulated under this Order."

- 5. Revise the second sentence of Finding No. 7 to read as follows:
 - ". . . intent to enroll Alpine II Burn Dump . . .
- 6. Add the following sentence to the end of Finding No. 8:

"The Regional Board received a copy of the Notice of Exemption on March 26, 2007."

- 7. Replace "Alpine 2" with "Alpine II" in:
 - Enrollment in General Order No. 97-11, A.1, A.2 and A.3;
 - Added Maintenance Specifications C.18, C.19 and C.20
 - Added Reporting Requirements E.13, E.14 and E.15
