GENERAL INFORMATION

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering amendments to the *Water Quality Control Plan for the San Diego Basin (9)* (Basin Plan) to renew and incorporate the revised conditional waivers of waste discharge requirements for specific types of discharge in the San Diego Region.

The Basin Plan amendment process is authorized under section 13240 of the Water Code. Basin Plan amendments are projects subject to the California Environmental Quality Act (CEQA) and the San Diego Water Board will be the lead agency. The San Diego Water Board wishes to obtain public input on this matter.

FILING OF ENVIRONMENTAL DOCUMENTS

Action on the proposed Basin Plan amendment will be taken in accordance with a regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare environmental documents under the CEQA [Public Resources Code section 21000 *et seq.*] and other applicable laws and regulations. In compliance with the State Water Resources Control Board's CEQA implementation regulations [23 CCR 3720 *et seq.*] the San Diego Water Board has prepared a technical report, initial draft of the Basin Plan amendment, and Environmental Checklist for this project [23 CCR 3776]. These documents will be available for review by July 6, 2007.

PUBLIC HEARING

The San Diego Water Board will hold a public hearing on this matter on August 8, 2007, during its regular meeting beginning at 9:00 a.m. The public hearing will be held at the San Diego Water Board's office, in the Board Room. The San Diego Water Board will deliberate on and consider action on the Basin Plan amendment at a subsequent meeting.

REQUEST FOR PUBLIC INPUT

Interested persons are invited to attend the hearing to present testimony. Oral statements will be heard, but for accuracy, testimony should be presented in writing. Written comments are due no later than Wednesday, August 8, 2007, at the close of the San Diego Water Board's public hearing. Submittal of written comments prior to August 8, 2007 is encouraged. Comments submitted prior to August 1, 2007 at

5 p.m. will be provided to the San Diego Water Board members in advance of the public hearing.
