**TENTATIVE ADDENDUM NO.1
TO
ORDER NO. R9-1998-0084**

**AN ADDENDUM FOR AN OWNERSHIP CHANGE AT KAMP ANZA RV RESORT
RIVERSIDE COUNTY**

The California Regional Water Quality Control Board, San Diego Region (hereinafter Regional Board) finds that:

1. Order No. R9-1998-0084 prescribes waste discharge requirements Kamp Anza LLC for discharges of septic tank effluent to a subsurface leach field at Kamp Anza RV Resort, located at 41560 Terwilliger Drive, Anza, California.
2. Kamp Anza LLC was comprised of Vince Reynolds, John E. and Sandra J. Grant, and Gordon and Katrin Utt.
3. The Regional Board was notified by Vince Reynolds that the transfer of ownership, documented in a letter received by the Regional Board on February 6, 2008, occurred in June 2006. The notification to the new owners, Terry and Marilyn Grant, of their responsibilities under Order No. R9-1998-0084 is documented in a Regional Board letter dated August 6, 2008.
4. This Order, which enforces the laws and regulations administered by the Regional Board, meets the California Environmental Quality Act (CEQA) (Public Resources Code section 21000, *et seq.*) involves the permitting of an existing facility and does not involve expansion beyond that existing at the time of adoption of this Order; therefore, this Order is categorically exempt to CEQA regulations pursuant to California Code of Regulations, Title 14, Chapter 3, Article 19, section 15301.
5. This Regional Board has notified the new owners and all known interested persons of the intent to prescribe an amendment to Order No. R9-1998-0084.
6. This Regional Board in a public meeting has heard and considered all comments pertaining to the proposed amendment.

IT IS HEREBY ORDERED, that in order to meet the provisions contained in Division 7 of the California Water Code and Regulations adopted thereunder, Terry and Marilyn Grant (hereinafter Dischargers) shall comply with all the requirements contained in Order No. R9-1998-0084 and Monitoring and Reporting Program R9-1998-0084; and

1. Notification: Kamp Anza LLC is liable for violations of Order No. R9-1998-0084 prior to the ownership transfer date and Terry and Marilyn Grant are liable for violations of Order No. R9-1998-0084 from the ownership transfer date forward.
