SUBJECT: Resolution for Approval of Hydromodification Management Plan

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will consider adopting Tentative Resolution No. R9-2010-0066, a Resolution for Approval of the Hydromodification Management Plan for the County of San Diego, the Incorporated Cities of San Diego County, the San Diego Unified Port District, and the San Diego County Regional Airport Authority at its regularly scheduled meeting on June 9, 2010.

Background

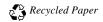
Provisions D.1.g and J.2.a of Order No. R9-2007-0001 (the San Diego County Municipal Storm Water Permit) require the incorporated cities of San Diego County, the San Diego Unified Port District, and the San Diego County Regional Airport Authority (Copermittees) to submit a Hydromodification Management Plan (HMP) to manage increases in runoff discharge rates and durations from all Priority Development Projects (PDPs), where such increased rates and durations are likely to cause increased erosion of channel bed and banks, sediment pollutant generation, or other impacts to beneficial uses and stream habitat due to increased erosive force.

On December 29, 2009, the County of San Diego, on behalf of the Copermittees, submitted a Final HMP to the San Diego Water Board. On January 14, 2010, the San Diego Water Board posted the Final HMP on the San Diego Water Board's website and initiated a 30-day public review and comment period. The San Diego Water Board received 3 comment letters on the Final HMP and has considered these comments in making revisions to the Final HMP. These revisions are described in Tentative Order No. R9-2010-0066.

Meeting Notice and Solicitation of Public Comments

The San Diego Water Board will receive public input on Tentative Order No. R9-2010-0066 by hearing oral testimony and considering written comments associated with the proposed action at its meeting on **June 9, 2010**, **beginning at 9:00 a.m.** in the San Diego Water Board Meeting Room, 9174 Sky Park Court, San Diego, California.

Written comments received after 5:00 p.m. on Tuesday, June 1, 2010 may not be provided to the San Diego Water Board members prior to the hearing.
