Hi Catherine, I got your voicemail about the disclosure. Here is some additional detail about the content of what we discussed. Please don't hesitate to call me with any questions.

- This was a brief meeting, roughly 30 to 45 minutes.
- Much of it was background discussion. Tim Shaheen and Eric Anderson have both been in the agriculture business, and there was discussion of the agriculture business.
- Tim Shaheen was also on the Los Angeles Regional Water Quality Control Board for a number of years, and there was discussion of that experience.
- We described the San Luis Rey Downs training facility and its history, and some of the background about why it
  is important to the region. It is a California Horse Racing Board approved training facility near Bonsall. As other
  horse-stabling facilities have closed, the horse-racing industry needs a place to stable horses in Southern
  California. The San Luis Rey Facility provides some stabling capacity, and is seeking to expand to meet increasing
  demand.
- We discussed the waiver in general terms. Eric Anderson mentioned that it could be relevant to the proposed expansion of the stables, and pointed us to Julie Chan as the appropriate staff person to discuss the waiver with. He also told us to fill out a disclosure because the Regional Board is taking action on renewing the waiver.
