All written comments pertaining to the Tentative Order to be considered by the San Diego Water Board must be received **no later than 5:00 p.m. on Wednesday, January 7, 2016**. Comments should be submitted electronically to sandiego@waterboards.ca.gov in text searchable Portable Document Format (PDF) or Microsoft Word format. Written comments can also be submitted via regular mail to the San Diego Water Board office at 2375 Northside Drive, San Diego, CA 92108. Please indicate in the subject line of the email or comment letter "Comment – Tentative Order No. R9-2016-0001, Attn Roger Mitchell." The early submission of written comments on the Tentative Order is encouraged. Written comments received by 5:00 p.m. on Wednesday, January 7, 2016, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received.

Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after 5:00 p.m. on Wednesday, January 7, 2015, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

Public Hearing for Consideration of Tentative Order Adoption

A public hearing on the Tentative Order will be held during the San Diego Water Board meeting scheduled on Wednesday, February 10, 2016, at the San Diego Regional Water Board Meeting Room, 2375 Northside Drive, San Diego, California, 92108.
