> MINUTES OF MEETING OCTOBER 12, 2016

At 9:00 a.m., Chairman Abarbanel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) at the Board Meeting Room, 2375 Northside Drive, Suite 108, San Diego, California.

**Item 3** – Minutes of Board Meeting: August 10, 2016:

Mr. Anderson moved to approve the minutes, and Mr. Morales seconded the motion. A roll call vote was taken, and Board Members Abarbanel, Anderson, Morales, and Strawn voted "aye." Board Member Warren abstained. The motion passed.

Kelly Dorsey responded to Board Member questions regarding the Supplemental Executive Officer's Report regarding the CEQA Scoping Meeting held on October 6, 2016.

Ms. Warren recognized the Ocean Conservancy for their efforts on the annual Coastal Cleanup Day on September 17, and Surfrider for their annual Paddle for Clean Water on September 27.

Mr. Anderson provided a report on the NGO Outreach Meeting held at Orange County Coastkeeper on September 19.
