MINUTES OF MEETING FEBRUARY 13, 2013

#### **Item 2** – Public Forum

Magdalena Certa and Laura Hunter, of the Environmental Health Coalition, addressed the Board regarding the channelization of the Rio Alamar.

Erik Basil, Chair of the Los Peñasquitos Canyon Citizens Advisory Committee, and Travis Pritchard, Water Quality Lab Manager for San Diego Coastkeeper, spoke regarding erosion and silting impact on Los Peñasquitos Lagoon.

Mr. Strawn invited Ms. Hagan to provide the Board with an update about enactment of SB 965, allowing ex parte communication for general orders, and Ms. Hagan provided the update.

Jill Witkowski, Waterkeeper for San Diego Coastkeeper, addressed the Board regarding improved public access to Board meetings through webcasts and allowing video testimony.

<u>Item 3</u> – Minutes of Board Meeting: December 12, 2012.

Mr. Morales moved that the minutes be approved, and the motion was seconded by Ms. Kalemkiarian. The minutes were approved by unanimous vote.

<u>Item 4</u> – Chairman's, Board Members', State Water Board liaison's, and Executive Officer's Reports. These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Fran Spivy-Weber provided an update on the budget and State Board matters.

Mr. Strawn spoke regarding recent meetings with the Board Members, the Executive Officer, and various municipal officials as part of the San Diego Water Board's Practical Vision.

Mr. Gibson followed up on Mr. Strawn's report, and he addressed other items in the Executive Officer's written report. He also provided an update on the location for the March Board meeting.

There was Board discussion about the Tentative Order, after which Mr. Morales moved to adopt the Consent Calendar, and Mr. Anderson seconded the motion. The Consent Calendar was adopted by unanimous vote.

Mr. Strawn called a recess at 10:28 a.m. and reconvened the meeting at 10:40 a.m.

Oscar Romo, with assistance from Jennifer Hazard-Leonard, provided an update on mapping trash and sediment sources in the Los Laureles and Matadero Canyons.

Mr. Strawn adjourned for lunch and Closed Session at 12:53 p.m. and reconvened the meeting in Open Session at 1:48 p.m.

<u>Item 8</u> — NPDES Permit Reissuance: City of San Diego, Discharges from South Bay Water Reclamation Plant to the Pacific Ocean via the South Bay Ocean Outfall, San Diego County (Tentative Order No. R9-2013-0006, NPDES Permit No. CA0109045). (*Joann Lim*)

After Mr. Strawn's opening statement and the administration of the oath, Joann Lim made her presentation.

Roger Bailey, Utilities Director for the City of San Diego, and Steve Myers, Deputy Utilities Director for the City of San Diego commented on the proposed Order.

Mr. Strawn closed the public hearing and called for a motion on the Tentative Order.

Mr. Morales moved to adopt Tentative Order No. R9-2013-0006 with an amendment to errata sheet No. 2 adding a provision that the Board may consider reopening the permit to require the discharger to evaluate costs and values of the monitoring program. The motion was seconded by Mr. Anderson. The Order with errata and the proposed amendment was adopted by a unanimous vote.

<u>Item 9</u> – Election of Regional Board Chair and Vice Chair for 2013. (*David Gibson*)

Dr. Abarbanel nominated Mr. Morales for Chair. The nomination was approved by a 4-0 vote, with Mr. Strawn abstaining. Mr. Morales then nominated Dr. Abarbanel for Vice Chair. Dr. Abarbanel declined the nomination, but nominated Mr. Strawn for Vice Chair. That nomination was approved by unanimous vote.
