### NOTICE OF AVAILABILITY AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing the draft Clean Water Act Sections 305(b) and 303(d) Integrated Report for the San Diego Region (Integrated Report) dated July 2016 for public review and comment. The draft Integrated Report includes the draft Staff Report, proposed Updates to Section 303(d) List (Appendix A), Categorical Lists of Water Body Segments (Appendix B through H) and other supporting information (Appendix I through K). The San Diego Water Board has tentatively scheduled to consider adoption of the draft Integrated Report at a public hearing during its regularly scheduled meeting on **October 12, 2016**. Details regarding the public hearing will be provided in a separate notice at a later date.

Written comments can also be submitted via regular mail to the San Diego Water Board office at 2375 Northside Drive, San Diego, CA 92108. Please indicate in the subject line of the email or comment letter "Comment – CWA Section 305(b)/303(d) Integrated Report, Attn: Xueyuan Yu." Written comments received by **5:00 p.m. on August 12, 2016**, will be provided to the San Diego Water Board members for their review in advance of the public hearing tentatively scheduled for October 12, 2016.

The San Diego Water Board will prepare written responses to significant comments that are timely received in advance of the public hearing (tentatively scheduled on October 12, 2016). Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on August 12, 2016**, will not be accepted, and will not be incorporated into the administrative record.
