**SUBJECT: Staff Enforcement Letter, 2015 Self-Monitoring Reports (SMRs) for U.S. Naval Base Point Loma (NBPL), Order No. R9-2014-0037, NPDES Permit No. CA0109363**

Mr. MacKelvey:

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has reviewed the following self-monitoring reports (SMRs) and technical reports submitted between April 2015 and September 2015 for the aforementioned facility:

- Quarterly SMRs – April 2015 through September 2015
- Annual SMRs – July 2014 through June 30 2015

The following is a summary of the San Diego Water Board's findings:

### **1. Violation – Unauthorized Discharge, Section III.A**

- a. On June 30, 2015, there was an unauthorized discharge of less than 1 pint of hydraulic oil from a crane into the San Diego Bay near North Pier at NBPL.

### **2. Violation – Failure to Monitor, Section VII.A. 4.h**

- a. No pH sample was collected during the Third Quarter 2015 monitoring period at Monitoring Location No. CS-001 (North Pier), and CS-002.

Pursuant to the California Water Code (CWC), the violations noted are subject to additional enforcement action(s) by the San Diego Water Board including a time schedule order, cease and desist order, cleanup and abatement order, imposition of administrative civil liability, referral to the district attorney for criminal prosecution, or referral to the attorney general. Administrative civil liability amounts that may be imposed by the San Diego Water Board under authority of CWC Section 13385 include up to \$10,000 per day, or up to \$10 per gallon for each gallon of waste discharged.
