HEARING PURPOSE

The San Diego Water Board will consider certification of the Final Environmental Impact Report (FEIR) and adoption of a Cleanup and Abatement Order (CAO) for discharges of metals and other pollutants into San Diego Bay in the vicinity of the shipyards. The San Diego Water Board will receive public testimony in ultimately deciding which entities will conduct necessary cleanup, the size of any area to be cleaned up, and the cleanup levels to be achieved.

CLEANUP DESCRIPTION

Cleanup may require dredging and disposal, capping, and/or natural recovery of the contaminated marine sediment.

CLEANUP LOCATION

The cleanup site is located along the eastern shore of central San Diego Bay, bounded by the Sampson Street Extension to the north and Chollas Creek to the south; and the National Steel and Shipbuilding Company and BAE Systems San Diego Ship Repair, Inc., facilities shoreline out to the San Diego Bay main shipping channel on the west.

REQUEST FOR PUBLIC INPUT

The public is invited to attend the public hearing and to present non-evidentiary comments (policy statements) beginning on Wednesday, November 9, 2011, at 5 p.m. Interested persons present prior to 5 p.m., may at the Chair's discretion, be heard prior to 5 p.m. Policy statements present legal and policy arguments, and statements concerning any of the issues that will be considered at the hearing. Policy statements may refer to evidence in the record, but cannot include any testimony or new evidence. The deadlines for submitting written comments on the CAO and Draft EIR already closed, but the public may make oral statements about the CAO and FEIR at the hearing.

The statements about the CAO and FEIR at the hearing. The deadline for submitting written comments to the San Diego Water Board on revisions to the CAO and the FEIR made on September 15, 2011, is 5 p.m. October 19, 2011.


ACCESSIBILITY
