The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is scheduled to hold a public hearing to consider adoption of Tentative Order No. R9-2015-0001, *An Order Amending Order No. R9-2013-0001, NPDES No. CAS010266, National Pollutant Discharge Elimination System (NPDES) Permit and Waste Discharge Requirements for Discharges from the Municipal Separate Storm Sewer Systems (MS4s) Draining the Watersheds within the San Diego Region* (Tentative Order).

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is scheduled to hold a public hearing to consider adoption of Tentative Order No. R9-2015-0001, An Order Amending Order No. R9-2013-0001, NPDES No. CAS010266, National Pollutant Discharge Elimination System (NPDES) Permit and Waste Discharge Requirements for Discharges from the Municipal Separate Storm Sewer Systems (MS4s) Draining the Watersheds within the San Diego Region (Tentative Order).
