ORDER NO. 93-045

RESCINDING WASTE DISCHARGE REQUIREMENTS FOR:

EAST BAY REGIONAL PARK DISTRICT
COYOTE HILLS REGIONAL PARK
FREMONT, ALAMEDA COUNTY

The California Regional Water Quality Control Board, San Francisco Bay Region (hereinafter called the Board), finds that:

1. On December 18, 1985, the Board adopted Order No. 85-136, Waste Discharge Requirements for East Bay Regional Park District (hereinafter called the Discharger) for the discharge of waste from an on-site septic tank located at Coyote Hills Regional Park in Fremont.
2. Coyote Hills Regional Park has four flush toilets that discharge an average of 150 gallons per day and up to a maximum of 300 gallons per day to the on-site septic tank. The waste from the septic tank flows to two oxidation ponds where the wastewater evaporates.
3. The Discharger submitted a letter dated January 21, 1993, informing the Board that the on-site septic tank has been connected to the Union Sanitary District lateral sewer line on January 19, 1993, and requesting that Order No. 85-136 be rescinded. The old septic tank pump station that pumped waste to the wastewater oxidation ponds has been dismantled, and the sewer line extending to the oxidation ponds has been disconnected.
4. The Waste Discharge Requirements prescribed by Order No. 85-136 are no longer applicable or necessary, since the waste disposal operations for which the Order was adopted have been terminated.
5. This Order will rescind the Waste Discharge Requirements prescribed by Order No. 85-136.
6. Adoption of this Order is exempt from provisions of Chapter 3 (commencing with Section 21100) of Division 13 of the Public Resources Code (California Environmental Quality Act), pursuant to Section 13389 of the California Water Code.
7. The Discharger and interested agencies and persons have been notified of the Board's intent to rescind Waste Discharge Requirements and have been provided an opportunity for a


public hearing and the opportunity to submit their written views and recommendations.

8. The Board , in a public meeting, heard and considered all comments pertaining to the proposed rescission action.


