RESCISSION OF INDIVIDUAL NPDES PERMITS and AUTHORIZING DISCHARGE UNDER GENERAL NPDES PERMIT 91-056 FOR:

UNOCAL; SHELL OIL CO; SANTA CLARA TRANSPORTATION AGENCY; VIKING MATERIALS CO; MISSION TRAIL CO; CHEVRON USA; LAIDLAW ENVIRONMENTAL SERVICES; BANK OF CALIFORNIA; SOUTHLAND CORPORATION; and TEXACO USA

The California Regional Water Quality Control Board, San Francisco Bay Region (hereinafter the Board) finds that:

1. The Board adopted Order No. 91-056 (General Permit), on April 17, 1991, specifying "General Waste Discharge Requirements for Discharges of Extracted and Treated Groundwater Resulting from the Cleanup of Groundwater Polluted by Fuel Leaks and other Related Wastes at Service Stations and Similar Sites". At present, 76 sites are being regulated under the General Permit.
2. Before the General Permit was adopted, the Board had adopted several individual NPDES Permits for sites that would fit the requirements of the General Permit. These NPDES Permits have expired or will expire before the General permit expires. The individual sites (hereinafter the Dischargers) are as follows:



3. Treatment systems for these sites employ either carbon adsorption, air stripping or a combination of the two. Flow rates vary from 3,000 to 36,000 gallons per day.
 4. A review of the Dischargers' monitoring data indicate that the Dischargers should be able to comply with the effluent limitations specified in the General Permit.

5. This Order will consolidate the thirteen Dischargers listed above under the requirements of the General Permit and rescind their individual permits.
6. The Dischargers and interested agencies and persons have been notified of the Board's intent to rescind the Dischargers' individual permits and allow their discharges under the General Permit. They have been provided with the opportunity to submit their written views and recommendations, and appear at the public hearing.
7. The Board, in a public hearing, heard and considered all comments pertaining to the discharges.

IT IS HEREBY ORDERED that the Dischargers, discharging treated groundwater polluted by fuel leaks and other related wastes at service stations and similar sites, their agents, successors, and assigns; in order to meet the provisions contained in Division 7 of the California Water Code and regulation adopted thereunder, and the provisions of the Clean Water Act as amended and regulations and guidelines adopted thereunder; shall comply with the following:

1. The Executive Officer will issue discharge authorization letters to the Dischargers for each specific site by August 1, 1993. The Dischargers shall comply with all sections of the General Permit immediately upon receipt of the discharge authorization letter.
2. Requirements prescribed by the General Permit will supercede the requirements prescribed by each Dischargers' individual permit. The following Orders are to be rescinded on August 1, 1993:

3. The Board may modify, or revoke this Order and/or reissue a new Order if present or future investigations demonstrate that the discharges governed by the General Permit and listed in this Order are causing or significantly contributing to adverse impacts on water quality and/or beneficial uses of the receiving waters.
