ORDER NO. 94-084

AMENDING SITE CLEANUP REQUIREMENTS AND CLEANUP AND ABATEMENT ORDERS
FOR THE DISCHARGERS CITED HEREIN

The California Regional Water Quality Control Board, San Francisco Bay Region (hereinafter called the Board), finds that:


1. The dischargers listed in Attachment A have been previously issued, pursuant to Section 13304 of the Water Code, the site cleanup requirements or cleanup and abatement orders listed in Attachment A.
2. Pursuant to Section 13304 of the Water Code, the dischargers listed in Attachment A are hereby notified that the Board is entitled to, and may seek reimbursement for, all reasonable costs actually incurred by the Board to investigate unauthorized discharges of waste and to oversee cleanup of such waste, abatement of the effects thereof, or other remedial action, required by the orders listed in Attachment A.
3. This action is an order to enforce the laws and regulations administered by the Board. This action is categorically exempt from the provisions of the CEQA pursuant to Section 15321 of the Resources Agency Guidelines.
4. The Board has notified the dischargers and interested agencies and persons of its intent under Section 13304 of the Water Code to prescribe amendments to the Orders listed in Attachment A, and has provided them with the opportunity for a public hearing and an opportunity to submit their written views and recommendations.
5. The Board, in a public meeting, heard and considered all comments pertaining to the discharge.

IT IS HEREBY ORDERED, that all Orders listed in Attachment A shall be amended to include the following Provision as the Order's last Provision:

The discharger(s) shall be liable, pursuant to Section 13304 of the Water Code, to the Board for all reasonable costs actually incurred by the Board to investigate unauthorized discharges of waste and to oversee cleanup of such waste, abatement of the effects thereof, or other remedial action, required by this Order. For those sites addressed by this Order that are enrolled in a State Board-managed reimbursement program, reimbursement shall be made pursuant to this Order and according to procedures established in that program. Any disputes raised by the

discharger(s) over the reimbursement amounts or methods used in that program shall be consistent with the dispute resolution procedures of that program.
