SUBJECT: NPDES Wastewater Program - Status of Permit Backlog Strategy

CHRONOLOGY: Program Status Report - January 11, 2006

DISCUSSION: At its January meeting, the Board directed staff to meet U.S. EPA's goal of no

expired NPDES permits by the end of 2007. Since that meeting, staff has met internally and with U.S. EPA staff on several occasions to develop a strategy to

neet that goal. Generally, the strategy involves:

• adding resources to the NPDES division;

- deferral of all but the most essential division tasks not related to permit issuance, reissuance, and enforcement; and,
- defining more clearly the time schedules and tasks to assure accountability for draft permits moving through the process.

Additional resources would come both from other divisions at the Board, and from U.S. EPA contractor support for drafting permits. The contractor support will allow us to also sustain the division's innovative projects described at the January meeting (e.g., electronic reporting system, sanitary sewer overflow reduction program, and pollution prevention). However, some pollution prevention work will be put on hold and directed towards permit reissuance. Also, expectations and timeframes for work products in the divisions are now more clearly defined in order to smooth the process internally, as well as externally for our work with U.S. EPA's contractor.

Attached is a draft commitment schedule provided to the U.S. EPA that meets their stated goal. The schedule is very aggressive and exceeds those of other regions. It is also double our previous rate. Despite this, with the additional resources and other changes planned, we are optimistic that we will meet it. The schedule shows a significant number of permits for this May and June. Staff development of these was already underway prior to January's meeting, but now with increased emphasis. Because development of each permit takes at a minimum 5 to 7 months from the initiation of staff work to Board consideration of a tentative order, the effects of this accelerated reissuance effort will be evident by August or September. After that, there will be about 3 to 4 permits each month.

One likely outcome of this effort will be that more permits will be contested. In recent years, most permits have been uncontested because we have allowed time for stakeholders to resolve differences. We have also allowed time for the permittee to collect additional data to resolve potential compliance problems related to new and more stringent limits. Committing to a reissuance schedule will no longer allow this to occur. However, we will endeavor to identify stakeholder issues early so that they can be addressed to avoid as many contested items and appeals as possible. We have also asked BACWA to help in this effort by informing their membership to be proactive in identifying issues, and completing studies prior to the reissuance process.

Board member Wolff, at the Board's February meeting, asked whether the reissuance schedule commitment is sustainable. The answer is no, not without additional resources. We hope that U.S. EPA's suggestion to re-examine an appropriate resource allocation with the State Water Board will result in more resources for us in the future. Given that all permits must be reissued, we will be faced with another backlog crisis in 5 to 6 years when the current load of permits will again expire.

As for the current backlog crisis, at the time this is written, final details for our commitment are still being worked out with U.S. EPA staff. By the time of the meeting, we hope to report that there is agreement, and that U.S. EPA will give the green light for contractor support so that we may proceed with drafting permits.
