2020 Scrap Metal Qualified SWPPP Developer/Practitioner Exams and Certified Persons ENGLISH and SPANISH Training Schedule

The Scrap Metal Storm Water General Permit, Order No. R8-2018-0069, requires persons who develop or implement a facility’s Storm Water Pollution Prevention Plan (SWPPP) and whom prepares a Corrective Action Plan (CAP) to have Regional Board certification. In addition, the Scrap Metal Storm Water General Permit requires certified persons who are properly trained and certified in sample collection, preservation and handling protocol.

The Scrap Metal Qualified SWPPP Developer (SM-QSD) and Scrap Metal Qualified SWPPP Practitioner (SM-QSP) certification exams will be held on March 12, 2020, ~~June 10, 2020~~ (**CANCELLED**), September 10, 2020, and December 9, 2020. The exam begins at 9:30 am and end at 12 noon. There will be Spanish language and English language versions available.

Exam is open book but electronic devices will NOT be allowed during exam. A valid Driver’s License or State Issued ID is required.
