

Warning Letters

For suppliers that are within 5 percentage points of meeting their conservation standard (Priority 3), warning letters are sent to remind suppliers that they should immediately take additional steps to enhance water conservation efforts and ensure that their conservation standard is met in future months.

Note that this strategy did not change with the February 2016 extended Emergency Regulation.
