City of Ukiah: Plan of Study Components- Recycled Water Master Plan

- 1) The recycled water service area that will be studied is the Ukiah Valley located in Mendocino County, California.
- 2) The potential source of recycled water is the City of Ukiah's Waste Water Treatment Plant tertiary treated effluent. The unit processes are an 8mgd Siemens Micofloc Trident Filtration Unit that provides tertiary treatment of the secondary effluent.
- 3) The current disposal method of the tertiary treated effluent is discharged to the Russian River per NDPES Permit #CA0022888.
- 4) See Attachment 3 for a map of the study area.
- 5) a. Water agencies having jurisdiction over the Ukiah Valley include:
 - 1) Redwood Valley Water District
 - 2) Calpella County Water District/Willow Water District/Hopland Public Utility District
 - 3) Rogina Water Company
 - 4) Millview Water District
- 5) b. Waste Water agencies having jurisdiction over the Ukiah Valley include:
 - 1) Ukiah Valley Sanitation District (outside of City limits)
- 6) The City of Ukiah has several potable water options, including surface and groundwater. It is the hopes of the City to offset potable water use through the development of a Recycled Water System. There is currently no recycled water used within the Ukiah Valley.
- 7) A stakeholder meeting was held February 28, 2011. City of Ukiah Staff was present as were representatives from Mendocino County Farm Bureau, Ukiah Valley Sanitation District, Redwood Valley County Water District, Willow County Water District, Rogina Water Company Inc, and the Mendocino County Russian River Flood Control and Water Conservation Improvement District. A public workshop is currently being planned for April.
- 8) See Attachment 4 for project schedule. To date, we are approximately one month behind the schedule.
- 9) We don't foresee any problem that may arise and delay the project.
- 10) The City of Ukiah is solely responsible for conducting the study. We have contracted with Carollo Engineers for their technical expertise and are already discussing the variety of options with the local stakeholders.
- 11) The proposed budget, Attachment 5, is estimated and contracted for a lump sum of \$145,987.
