Searching for NPDES Wastewater Facilities

1. Go to

2. Select click on the "Region" button.

3. Under "Program" select "NPDES."



4. Under "Facility Type" select the type of facilities you are interested in. The example below is for "Wastewater Treatment Facility." Hold the "Shift" key for multiple selections. Do not select any facility type if you want a list of all NPDES permitted-facilities that discharge wastewater.



5. Click on "Run Report."

6. The report for "Wastewater Treatment Facility" is shown below. It shows "Major" and "Minor" facilities. Note, the "Minor Facilities" are subdivided into "General" and "Individual." You can select to see the facilities under each category by clicking on the total number at the bottom of each list.
