REISSUANCE OF STATEWIDE GENERAL
NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT FOR
BIOLOGICAL AND RESIDUAL PESTICIDE DISCHARGES TO WATERS OF THE UNITED
STATES FROM VECTOR CONTROL APPLICATIONS
(VECTOR CONTROL PERMIT)

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will hold a public hearing to consider adoption of the proposed Vector Control Permit. The proposed permit will update Water Quality Order 2011-0002-DWQ. The public hearing to consider adoption of the proposed permit will be on:

BACKGROUND

In March 2011, the State Water Board adopted the Vector Control Permit, which covers the point source discharge of biological and residual pesticides resulting from direct and spray applications for vector control. The permit will expire in February 2016. The proposed permit serves as a reissuance of the permit for a new five-year term and will have the changes described below.

The United States Environmental Protection Agency exempted pesticide products containing active ingredients listed in title 40 Code of Federal Regulations, section 152.25(f) from the requirements of the Federal Insecticide, Fungicide, and Rodenticide Act, alone or in combination with other substances, provided that all of the criteria of the regulations are met. This proposed permit will add the listed active ingredients to be regulated by the permit.

When the California Department of Pesticide Regulation registers a new active ingredient for the control of aquatic animal invasive species, the permit must be amended to add the new active ingredient and its corresponding receiving water limitations before dischargers may begin using the active ingredient. Furthermore, when the California Department of Pesticide Regulation registers a new active ingredient, the permit may also be amended to allow dischargers a regulatory exception from complying with receiving water limitations for the pollutant in accordance with the State Water Board Policy for Implementation of Toxics Standards for Inland Surface Waters, Enclosed Bays, and Estuaries of California, and/or the California Ocean Plan. Amending the permit on a case-by-case basis is resource intensive for the State Water Board.

This proposed permit adds language to the permit that delegates the State Water Board's authority for the actions described above to the Executive Director or his/her designee.
