Hello.

I am Joey Racano, a resident of Los Osos, California and a co-founder of the Ocean Outfall Group.

I have three comments on the issue of single-pass or once-through cooling:

1. Never be fooled by what sleight-of-hand or PR experts refer to as 'transference'.

Transference is when they keep you looking at the intake, talking about a briny discharge, about hot water, while the true damage is being done by the INTAKE, plankton destruction, (intrainment, impingement)...

That's not to say that thermal discharge isn't bad- I've seen Diablo pour out so much hot water that it killed everything in the lagoon, heat shock. It was a sad site, I saw footage on a friends computer (he worked for a regulatory compliance company) and there were piles and piles of fish coming in on a conveyer belt and I felt terrible for the guy, knowing his love for creatures. I said, "wow, thats a lot of dead fish", and he answered he only got to study a small sample of them, because another giant pile was coming on the conveyer every 5 minutes!

OK, #2-

Beware the 'piggy-backing' of desal units on existing OTC intakes, because, like in Encinas, the desal people will try to 'grandfather in' using the intake, continuing the destruction, and yes, desal is every bit as destructive as the power plant was.

Case in point:

Studies showed that while a power plant killed 95% of the plankton and creatures, the addition of desal to the process then killed the remaining 5%!

Don't ya love it?

In Morro Bay, the amount of wastewater being generated by the community and sent to the wastewater treatment plant seems to be more than what the plant operators say is discharging from the WWTP outfall. This may mean that the power plant outfall is being used to dump some of the effluent! This is exactly what is happening at Diablo, and this possibility should be considered when discussing the merits of phasing out OTC forever.


