# NOTICE OF ADOPTION MEETING

### GENERAL EXCEPTION TO THE CALIFORNIA OCEAN PLAN WASTE DISCHARGE PROHIBITION FOR SELECTED DISCHARGES INTO AREAS OF SPECIAL BIOLOGICAL SIGNIFICANCE, INCLUDING SPECIAL PROTECTIONS FOR BENEFICIAL USES AND THE ASSOCIATED PROGRAM EVIRONMENTAL IMPACT REPORT

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will consider adoption of a General Exception that includes Special Protections for Selected Storm Water and Nonpoint Source Discharges into Areas of Special Biological Significance, as well as a Program Environmental Impact Report for the regulatory action above. The location and time of the meeting are provided below.

## BACKGROUND

The State Water Board, under <u>Resolutions No. 74-28</u>, <u>74-32</u>, and <u>75-61</u>, designated Areas of Special Biological Significance (ASBS) in the adoption of water quality control plans for the control of wastes discharged to ocean waters. To date, 34 coastal and offshore island sites have been designated ASBS. Since 1983, the California Ocean Plan (Ocean Plan) has prohibited waste discharges to ASBS.

Similar to previous versions of the Ocean Plan, the 2009 Ocean Plan states: "Waste shall not be discharged to areas designated as being of special biological significance. Discharges shall be located a sufficient distance from such designated areas to assure maintenance of natural water quality conditions in these areas." The Ocean Plan further states, however, that "The State Board may, in compliance with the California Environmental Quality Act, subsequent to a public hearing, and with the concurrence of the Environmental Protection Agency, grant exceptions where the Board determines: a. The exception will not compromise protection of ocean waters for beneficial uses, and, b. The public interest will be served."

On October 18, 2004, the State Water Board notified responsible parties to cease storm water and nonpoint source waste discharges into ASBS or to request an exception under the Ocean Plan. The State Water Board has received 27 applications from nonpoint source dischargers and National Pollutant Discharge Elimination System (NPDES) permitted storm water dischargers for an exception to the Ocean Plan prohibition against waste discharges to ASBS.

Special conditions have been proposed in the General Exception to limit point source storm water and nonpoint source discharges, providing Special Protections for marine aquatic life and natural water quality in ASBS. The requirements in the proposed Special Protections may be summarized generally to eliminate dry weather runoff, ensure that wet weather runoff does not alter natural water quality in the ASBS, and that adequate monitoring be conducted to determine if natural water quality and the marine life beneficial use is protected. At its October 18, 2011 meeting the State Water Board considered the General Exception/Special Protections for adoption. At that time the State Water Board decided not to adopt but instead directed staff to complete its response to comments and to make any minor changes based on consideration of the comments, and to bring the Special Protections back to the Board for adoption in early 2012. In response, staff has revised its draft Special Protections to include minor additions and clarifications based on comments received in the public process. These revised Special Protections are being released now, in advance of the adoption meeting, with changes from the previous draft indicated in strikeout and underline text.
