### What is the College of Storm Water?

The Water Board Academy is a highly successful internal institution that provides technical and leadership development for Water Board employees and our partners. Since its inception in 2003 the Academy has provided over 1,500 training events for 40,000 individuals. In 2010 the Water Board Academy created the College of Storm Water to focus organizational development on topics related to the storm water program. In the past two years the College of Storm Water hosted a series of training events on the new Construction General Permit (inspections, enforcement, lessons learned) and is offering a new Hydromodification Seminar Series along with other classes.

#### What is the purpose of this seminar series?

The Southern CA Coastal Water Research Project (SCCWRP) hydromodification report contains a lot of technical content that deserves to be fully discussed and vetted by all stakeholders. The seminar series main objective is to provide a venue to distribute and discuss the report content.
