# 2<sup>nd</sup> REVISED NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND NOTICE OF PUBLIC HEARING

DRAFT STATEWIDE GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT FOR THE DISCHARGE OF STORM WATER ASSOCIATED WITH INDUSTRIAL ACTIVITIES (INDUSTRIAL GENERAL PERMIT)

The State Water Resources Control Board has extended the public comment period for this item. The due date for written public comments has been extended from 12:00 noon on Thursday, September 12, 2013 to 12:00 noon on Thursday, September 19, 2013.

**NOTICE IS HEREBY GIVEN THAT** the State Water Resources Control Board (State Water Board) will receive public comments on the Draft Industrial General Permit issued on July 19, 2013 (July 2013 Draft Industrial General Permit).

**NOTICE IS ADDITIONALLY HEREBY GIVEN THAT** the State Water Board will hold a Public Hearing on the July 2013 Draft Industrial General Permit. A quorum of State Water Board members will be present at the public hearing; however, the State Water Board will not take any final action at the hearing. ### **BACKGROUND**

On April 17, 1997, the State Water Board adopted Water Quality Order 97-03-DWQ for regulation of storm water discharges associated with industrial activity. Water Quality Order 97-03-DWQ has expired but remains in effect until a new industrial general permit is adopted. Staff of the State Water Board initiated an effort to reissue the industrial general permit in 2003. Concerns raised at that time regarding the role of numeric effluent limitations in storm water permits halted this effort.

On June 19, 2006, a panel of storm water experts submitted a report to the State Water Board titled: "The Feasibility of Numeric Effluent Limits Applicable to Discharges of Storm Water Associated with Municipal, Industrial and Construction Activities." The State Water Board considered the report's conclusions and recommendations and in January 2011 and July 2012 issued drafts of the industrial general permit for public comment. Many of the comments received on the drafts addressed increased costs and the imposition of numeric effluent limitations.

Based on the previous comments received, the draft permit has been revised. As compared to prior drafts, the July 2013 Draft Industrial General Permit provides a reduced cost of compliance, excludes numeric effluent limitations, and streamlines the regulatory process while protecting water quality.
