Proposed Revisions to the 303(d) List of Impaired Water Bodies and Consideration of an Integrated Assessment Report for the Central Valley Region

The Clean Water Act requires states to conduct an assessment of the quality of all their waters (Section 305b) and develop a list of those that are "impaired or threatened" (Section 303d). A Report has been prepared that integrates the two assessment efforts into one Integrated Report.

Public Hearing

The Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) will hold a public hearing to consider the Integrated Report and to consider proposed revisions to the list of impaired water bodies developed pursuant to Section 303(d) of the Federal Clean Water Act. The impaired water body list includes a proposed schedule for addressing impairments. The hearing is specific to waters in the jurisdiction of the Central Valley Water Board.

Oral testimony will be limited in time by the Water Board Chair.
