STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 2010–0040 – REVISED

APPROVING THE 303(d) LIST PORTION OF THE PROPOSED 2010 INTEGRATED REPORT, CLEAN WATER ACT SECTION 303(d) LIST OF WATER QUALITY LIMITED SEGMENTS AND CLEAN WATER ACT SECTION 305(b) ASSESSMENT OF SURFACE WATER QUALITY

WHEREAS:

- 1. Section 303(d) of the federal Clean Water Act (CWA) requires States to identify surface waters that do not meet applicable water quality standards.
- 2. The list of water quality limited segments identified according to CWA Section 303(d) must include a description of the pollutants not meeting standards and needing to be addressed.
- 3. The proposed California 2010 Integrated Report is a compilation of the Regional Water Boards' 2008 Integrated Reports with State Water Board staff recommendations for additions, deletions or changes.
- State Water Board staff and Regional Water Board staff used the Water Quality Control Policy for Developing California's CWA Section 303(d) List (Listing Policy) in developing the changes to the 303(d) List.
- 5. In developing the proposed 2010 Integrated Report Section 303(d) List, Regional Water Board and State Water Board staff has considered all readily available data and information.
- State Water Board staff has made recommendations to add, remove, or change the list of water body-pollutant combinations on the proposed 2010 Integrated Report Section 303(d) List.
- 7. On June 15, 2010 the State Water Board held a workshop to hear comments on the 2010 Integrated Report.

THEREFORE BE IT RESOLVED THAT:

The State Water Board:

- 1. Approves the 303(d) List portion of the 2010 Integrated Report, which is available on the State Water Board's website at the link below with five changes that are described below: http://www.waterboards.ca.gov/water_issues/programs/tmdl/integrated2010.shtml.
 - 1.1 Remove the Silviculture source from San Vicente Creek Sedimentation List
 - 1.2 Do Not List Santa Clara River Reach 5 and Reach 6 for Bioassessment
 - 1.3 Do Not List either the San Joaquin River or its tributaries, the Merced, the Tuolumne, and the Stanislaus for Temperature
 - 1.4 Do Not List multiple water bodies for *E.Coli* in Santa Ana Region
 - 1.5 Do Not List multiple water bodies for Metals in Santa Ana Region

2. Authorizes the Executive Director or designee to transmit the attached 2010 Integrated Report and other supporting information to the U.S. Environmental Protection Agency for approval of the 303(d) List.
