2010 Integrated Report: 303(d) List

- ➤ Staff reviewed 1,205 listing decisions made by Regions
- ➤ Staff made <u>no</u> changes to approximately **91%** of proposed listings by Regions
- ➤Of the **9%** which were changed by State Water Board staff, **6%** were requested by the Regional Water Board staff due to mistakenly omitted listings
- ➤ 3% of the changes recommended by State Water Board staff were not requested by the Regional Water Boards

- 3,507 total listings


