I am providing the following comments regarding the proposed Delta Tunnels:

Not only will the tunnels NOT serve to add or enhance any additional water passing to the San Francisco Bay — quite the contrary. It is a very expensive project and provides no guarantees for water users. Only users south of the Delta will benefit, to the detriment and destruction of Delta farm and migrating fish.

It is an incredible financial risk to water users and taxpayers.

It will likely increase salt water intrusion further into the Delta while increasing exports from an already drought-affected Delta.

Big Ag is seeking to now drain the Sacramento River because it has not prudently managed its existing contract water and ground water to provide for future needs.

The Tunnels will imperil protected species via a scheme that isn't even legal, as Federal agencies are not permitted to adversely alter critical habitat that is explicitly protected for the recovery of endangered fish.

It is entirely inappropriate that CA State agencies are already seeking Tunnel construction permits — before the comment period has ended. Also, So Cal water agencies are seeking to buy up Delta farms for the Tunnels, which constitutes a water grab, that would permanently harm No Cal water users, especially those in the Delta.

Funds intended for the Delta Tunnels could better be spent on shovel-ready water sustainable projects in California. It has been reported that the cost of the tunnels, after including borrowing interest will run to \$60 billion+. It would be money wasted — only serving wealthy capital venture “farmers” on lands much more appropriate for solar farms.

This project is not only insulting to Northern California water users but is fiscally irresponsible. Please dump this idea and use available funding for more realistic and sustainable projects.



On behalf of Central Basin Municipal Water District (Central Basin) Board of Directors, we would like to provide the following comments on the Bay Delta Conservation Plan/California WaterFix (BDCP/WaterFix) and its recirculated draft environmental impact statement/report released on July 10, 2015.

Central Basin relies on State Water Project (SWP) supplies as an important component of its local water supply portfolio. The SWP is uniquely capable of capturing significant quantities of wet-period supplies, allowing the Metropolitan Water District of Southern California to store these supplies for use during drought impacted conditions. Were it not for these supplies Metropolitan had stored prior to this historic drought cycle, there would be severe impacts to water shortages. The ability of the SWP to reliably capture wet-period water is at severe risk due to the existing configuration of the pumping system, regulatory constraints and long-term threats due to climate change and catastrophic natural events such as earthquakes and flooding.

Central Basin remains supportive of the recently released proposed configuration of the water supply improvements, which includes new intakes in the northern Delta and would provide the opportunity to divert high-quality supplies and address reverse-flow conditions in the southern Delta.

We appreciate the exhaustive efforts of both the state and federal administrations to advancing this process so that a final project and proposal can be advanced. Again, thank you for your efforts and for considering our comments.

I write as both citizen of California and as a scholar of California's Delta. For the past year I have been working on a history of the Delta for the Delta Protection Commission. In that capacity I have learned much about the historic uses of the Delta and the application of its water, primarily in the agricultural sector. It is a history of successful management of an engineered waterscape that barely resembles the original Delta of 1850. Yet it still flows and supports both human and non-human life.

The tunnels that are proposed by Governor Brown will undoubtedly benefit those living south of the Delta and the Bay Area. But at what cost to the environment of the present Delta? The smaller farms and orchards of the Delta lack the demographic and economic numbers to compete with agribusinesses and urban areas of central and southern California; yet they should be protected. As well the wildlife and wetlands that have been part of the restoration projects of the U.S. Fish & Wildlife Service, The Nature Conservancy, and the counties within and on the edges of the Delta.

In short, I oppose the tunnel projects and favor instead more reservoir storage and stricter regulatory powers over water for all stakeholders, including agriculture, but especially urban developers with intentions of compromising water supply with additional construction of housing along the Delta's rim.
