This petition seeks to increase the place of use to cover the entire 320 acres of proposed and existing vineyard, and to add heat control as a purpose of use. Historically, the 320 acres have been pear orchard. 155 acres have been converted to vineyard, and the remaining 165 acres will be planted to vineyard by 2015.
