This change petition under Water Code §1707 is submitted in connection with the Repetto Storage and Forbearance Project, in which the Petitioner's existing off-stream reservoir is being enlarged to allow the collection and storage of water in the wet season to provide an alternative source of water during the dry season.

Currently, the Petitioner diverts water for irrigation use between April 1 and November 1 annually under his adjudicated riparian rights quantified as Allotment No. 214 in Decree No. 355792 issued by the Superior Court for San Mateo County. As part of the project, the Petitioner will sign a 20-year forbearance agreement with the San Mateo County Resource Conservation District, agreeing to forbear diversion from August 1 through November 1 annually. The purpose of this petition is to add instream use for fish, wildlife, and recreation as allowable uses of water under Petitioner's riparian rights, to make clear that any and all water left instream by Petitioner pursuant to the project is being put to beneficial use and not abandoned.

No construction, grading, diversion, discharge of waste, or other activities with environmental impacts will result from this change petition. Such activities will result from the construction and operation of the enlarged storage reservoir, and are addressed in Application 32701 and supporting documents.
