Hole in the Ground Creek is a spring sourced tributary that flows into the Shasta River from the east near River Mile 34.5, contributing cold water flows and cold water habitat for coho salmon, Chinook salmon, and steelhead trout. TNC owns water rights totaling 1.5 cubic feet per second (cfs) on Hole in the Ground Creek at six different POD's (#167-172) pursuant to the Shasta River Adjudication and Decree (Decree) in Siskiyou County, California. By this Petition for Instream Flow Dedication (Petition)², TNC seeks to dedicate up to 1.5 cfs to instream uses for the purpose of preserving and enhancing fish and wildlife resources.

TNC has the sole right to divert water on Hole in the Ground Creek. As stated in the Decree, these water rights are for direct diversion from the natural and developed flow of Hole in the Ground Creek during the period between April 1st and October 1st of each year for beneficial use on 67.2 acres. Diversions #167-172 are described in the Decree as "Louie Brothers Ditches Nos. 1 to 6" and have priority dates as follows:

0.01 cubic foot per second—priority April 1, 1893
1.37 cubic foot per second—priority February 15, 1898
0.08 cubic foot per second—priority April 1, 1898
0.04 cubic foot per second—priority April 1, 1900
1.50 cubic foot per second—total

Diversions within the Hole in the Ground Creek system are administered as part of the Scott and Shasta Watermaster District (SSWD).³

Pursuant to this Petition, water withdrawals from Diversion #167-172 in certain circumstances will be reduced or curtailed during some or all of the irrigation season for the purpose of preserving and enhancing fish and wildlife resources in Hole in the Ground Creek and the Shasta River. Decisions about whether and when diversions will be reduced or curtailed will be made by TNC and the Department of Fish and Game in coordination with the Watermaster, based on natural flow conditions, water temperatures, biological needs of fish and wildlife and other relevant considerations.

TNC requests that the water that is subject to this dedication be in addition to water that is, or may in the future be required, to be used for instream purposes to satisfy any applicable federal, state, or local regulatory requirements governing water quantity, water quality, instream flows, fish and wildlife, wetlands, recreation, or other instream beneficial uses. TNC further requests that the California State Water Resources Control Board and all other state and local agencies, as well as the courts, not credit the water subject to this petition towards compliance with any regulatory requirements, including any existing or future minimum instream flow requirements, but rather this water

² As the holder of a pre-1914 appropriative right, TNC is not required to obtain State Water Resources Control Board approval to change the place of use, purpose of use or point of diversion of its water right. Water Code §1706; see also *Barnes v. Hussa* (2006) 136 Cal.App.4th 1358. Nonetheless, TNC submits this Petition pursuant to Water Code §1707 in the interest of ensuring that its proposal to include as a purpose of use *preserving and enhancing fish and wildlife resources* is adequately documented and enforceable.

Irrigation.

Proposed Purpose of Use:

Irrigation and preserving and enhancing fish and wildlife resources.

Present Place of Use:

Since TNC purchased the property in 2009, irrigation has continued as it had prior to TNC's acquisition. However, since 1932 when the decree was adopted, the place of use for POD #167-172 has changed. There have been slight changes over time due to improved irrigation infrastructure and more efficient use of other nearby POD's. The acreage listed in Table 1 and shown on Map 1 describes the acres outlined in the decree and also shows the revisions to the place of use. This amendment does not change the total use on any given day for either irrigation or instream benefits and will not exceed the decreed amount of the water right from Diversion #167-172.

Proposed Place of Use:

Irrigation as described in Table 1 and shown on Map 1. The instream place of use for preserving and enhancing fish and wildlife resources would be an instream dedication reach from the POD (upper limit of project) to the mouth of the Shasta River (lower limit of project), as shown on Map 2 and described as follows:

Upper Location of Flow Dedication Reach (location at Point of Diversion #168): NAD83 10N 548032.00e 4603368.26n

Downstream location of flow dedication reach (near the mouth of the Shasta River): At the USGS gage # 11517500 (Shasta River near Yreka, Ca): NAD83 10N 534025.088e 4630969.301n

Hole in the Ground Creek Unit Irrigation

The Hole in the Ground Creek Diversions #167-172 are located on the southern boundary of the property and are approximately 0.5 miles upstream from Hole in the Ground Creek's confluence with the Shasta River. Since TNC purchased the property in 2009, irrigation has continued as it had prior to TNC's acquisition. All diversions are combined and water is diverted from a single site—Diversion #168. To irrigate, the headgate is closed which creates an impoundment that raises the level of the water and allows water to flow into the diversion ditch. This diversion irrigates fields to the west of the diversion and is typically run on a continuous basis. By adding the instream use for preserving and enhancing fish and wildlife resources as a beneficial use, the total use on any given day for either irrigation or instream benefits will not exceed the decreed amount of TNC's water rights on Hole in the Ground Creek.

Other Water Diverters in the Project Area

Below is a list of the water diverters in the project area. Those diverters above the bold line have a lower priority than the Priority associated with Diversions Number 167-172 (Priorities 15, 17, 18, and 20)⁴. These lower priority rights are those rights that will need to be bypassed in the event that there is not enough water in the system to accommodate the instream dedication and all other water rights downstream.

Enclosed you will find a copy of eight 1707 Petitions (Petition for Instream Flow Dedications) for waters rights owned in association with Shasta Big Springs Ranch. These petitions are being submitted to the State Water Resources Control Board, Division of Water Rights with the purpose of adding fish and wildlife as a beneficial use to these water rights.

These eight petitions are for water rights that total 18.11 cubic feet per second (cfs) in the Shasta River Watershed and include the following Points of Diversion (POD):






