SUBJECT OF WORKSHOP

The State Water Resources Control Board (State Water Board) will hear comments regarding Sonoma County Water Agency's subject petition and the Division of Water Rights Order WR 2007-0015-DWR, dated May 10, 2007, approving the change.

BACKGROUND

On May 10, 2007 the Division of Water Rights issued Order WR 2007-0015-DWR approving Sonoma County Water Agency's (SCWA) April 27, 2007 petition for a Temporary Urgency Change to the subject permits. SCWA submitted the petition pursuant to California Water Code section 1435. The Order approves the reduction of instream flow requirements for the Russian River from May 1 through October 28, 2007. The Order, in effect, reduces minimum flows for the Russian River from normal-year criteria to dry-year criteria as defined in State Water Board Decision 1610.

PARKING AND ACCESSIBILITY




Due to enhanced security precautions at the Joe Serna, Jr. (Cal/EPA) Building, all visitors are required to sign in prior to attending any meeting. Visitors can sign in and obtain badges in the Visitor and Environmental Services Center, which is just inside and to the left of the building's public entrance. Visitors may be asked to show valid picture identification. Valid identification can take the form of a current driver's license, military identification card, or state and federal identification cards. Depending on the size and number of meetings scheduled on any given day, the security check-in could take from three to fifteen minutes.
