### **Notice of Temporary Permit Application T033282**

Triangle T Water District (Applicant) has filed an application for a temporary permit with the State Water Resources Control Board (State Water Board), Division of Water Rights (Division) pursuant to Water Code section 1425 et seq. The Applicant requests authorization to appropriate surface water for underground storage as described below.

Pursuant to Water Code section 1428, the State Water Board may issue a temporary permit in advance of public notice. Consequently, a temporary permit may be issued on the application prior to, during, or after this noticing period.

# **Summary of the Temporary Permit Application**

#### Source:

The source streams are Chowchilla and Eastside Bypasses, tributary to the San Joaquin River, thence the Pacific Ocean.

### County:

The proposed project is located in Madera County.

#### **Points of Diversion:**

Surface flow would be diverted at a total of 37 points of diversion located along the Chowchilla and Eastside Bypasses, all within Sections 2, 3, 4, 10, 11, 13, 14, 19, 20, 24, 28, 29, 30, 33, and 34, Townships 9, 10, 11, and 12 South, Ranges 13, 14, and 15 East, Mount Diablo Base and Meridian. Of the 37 points of diversion, there are 11 points that have an existing diversion structure or pump station and 26 are new proposed sites, which will use temporary pumping facilities.

#### Amount:

The total amount requested is 74,350 acre-feet by diversion to underground storage. This amount is inclusive of water potentially directly diverted for incidental irrigation as a result of on-farm recharge practices. The combined maximum rate of diversion is 750 cfs.

### **Season of Diversion:**

The season of diversion is from January 1, 2022 to June 14, 2022.

#### **Purpose of Use:**

The purpose of use is irrigation.

#### Place of Use:

The place of use consists of 47,005 acres of agricultural lands within the Applicant's service area and the Madera County GSA boundary as shown on the map filed with the State Water Board.

### **Location and Type of Infiltration:**

Infiltration would occur on up to 2,946 acres of agricultural lands (on-farm recharge) within the District's service area and the Madera County's GSA boundary overlying the Chowchilla subbasin. Water will be diverted from the bypasses and conveyed through existing irrigation systems. The water will be spread onto fields of crops and small berms will be used to contain the water as needed. Diverted water will be stored in the shallow unconfined aguifer.

## **Operations and Accounting:**

Water stored underground would be extracted by overlying well-owners for irrigation use within the Applicant's service area during the 2022 irrigation season. The Applicant intends to ensure that all water diverted and stored under any temporary permit issued pursuant to T033282 is extracted by users onto agricultural lands within the place of use during the 2022 irrigation season prior to extraction of other types of underground water. Flow meters will be installed at the diversion points to measure the amount of water diverted and meters will be installed on the wells to measure amount of water extracted from the aquifer for beneficial use.

# **Procedure for Submitting Objections**

Pursuant to Water Code section 1428, subdivision (d), any interested person may file an objection to the temporary diversion and use of water, with copy to the Applicant. Objections must be received or postmarked by the State Water Board by **4:30 p.m.** on **April 11, 2022**.
