NOTICE OF AVAILABILITY OF DRAFT TECHNICAL APPENDICES TO THE SUBSTITUTE ENVIRONMENTAL DOCUMENT FOR POTENTIAL CHANGES TO THE SAN JOAQUIN RIVER FLOW AND SOUTHERN DELTA WATER QUALITY OBJECTIVES AND THE ASSOCIATED PROGRAM OF IMPLEMENTATION

The State Water Resources Control Board (State Water Board) has released for public review three draft technical appendices to the substitute environmental document (SED) being prepared in support of potential changes to the San Joaquin River (SJR) flow and southern Delta water quality objectives and the program of implementation for those objectives contained in the 2006 Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (2006 Bay-Delta Plan).

The 2006 Bay-Delta Plan identifies beneficial uses of water in the Bay-Delta, water quality objectives to protect those uses, and a program of implementation to achieve the water quality objectives. Pursuant to the State Porter-Cologne Water Quality Control Act (Porter-Cologne) and the federal Clean Water Act, the State Water Board is required to regularly review and update the Bay-Delta Plan. The State Water Board initiated the review and update of the 2006 Bay-Delta Plan in 2009 in a phased fashion. The review of the SJR flow and southern Delta water quality objectives and program of implementation was initiated in 2009 and represents the first phase of the State Water Board's review of the SJR flow and southern Delta water quality objectives and program of its southern Delta Plan. The subject SED and technical appendices pertain only to the first phase of the State Water Board's review of the 2006 Bay-Delta Plan: SJR flow and southern Delta water quality objectives and the associated program of implementation. In compliance with the California Environmental Quality Act, the SED will identify a reasonable range of alternatives and will evaluate any significant environmental impacts that may be associated with potential changes to the SJR flow and southern Delta water quality objectives and program of implementation and will identify possible ways to minimize the significant effects of these alternatives. The SED will also be prepared in compliance with the requirements of Porter Cologne, including the requirement to consider economics when developing and adopting changes to the Bay-Delta Plan.

The State Water Board plans to release a draft of the entire draft SED in late April. Upon release of the draft SED, the State Water Board will identify a date by which comments on the draft SED, including the three appendices that are being released today, are due. There will not be a separate comment period for these three appendices. The State Water Board is releasing these three draft technical appendices now to give interested parties additional time to review these important technical appendices as they represent some of the very important factors that the State Water Board will need to take into consideration as it balances competing uses of water in its future deliberations.

The three draft technical appendices to the SED cover the following topics:

- <u>Scientific Basis for Alternative San Joaquin River Flow and Southern Delta Salinity</u> <u>Objectives (Scientific Report)</u>: This revised draft report describes the scientific information and tools needed to consider potential changes to SJR flow and southern Delta water quality objectives and their associated program of implementation. The draft Scientific Report was first released for public review and comment in October 2010. - <u>Agricultural Economic Effects of Lower San Joaquin River Flow Alternatives (Agricultural Economics Report)</u>: The analysis in this appendix estimates the potential effects to agricultural production and related sectors of the Lower SJR watershed economy that could occur with changes to surface water diversions resulting from a range of SJR flow alternatives.
- <u>Hydropower and Electric Grid Analysis of Lower San Joaquin River Flow Alternatives</u> (<u>Power Production Report</u>): This appendix analyzes the potential effects on hydropower generation and electric grid reliability in the Lower SJR watershed that could occur under a range of SJR flow alternatives.
