Dear Mr. Paoli:

For the past year negotistions have been under way between my office and your Againcy with respect to use of the American River water in western Placer County. These segotistions have been conducted with a view to resolving the apparent conflict between proposed diversions into western Placer County under your Middle Fork American Biver project and the Cantral Valley Project as to respective Fights to the use of water from the American River; to assure the United States optimum accomplishments in the operation of Folsom Reservoir as a mit of the Central Valley Project; to assure the west for the Bonstruction of the Auburn Unit of the Cantral Valley Project; and to provide a firm water supply to your Agency for western Placer County's future water meeds. Our megotistices have resulted in an agreement on the following terms to be incorporated in a contract between the Dhited States and the Placer County Water Agency. The Commissioner of Reclamation and the Secretary of the Interior have approved these -----

(a) The Agency, pursuant to water paralts to be obtained by it from the State Water Rights Board, may divert the following amounts of water from the natural flow of the Amarican River and from the natural flow of the Amarican River as regulated by its works without charge into wastern Placar County during a normal year on the basis of 5-year intervals:

(c) The Agency will be required to purchase the following minimum amounts of water from the Central Valley Project during mormal years on the basis of 5-year intervals:

(d) The definition of critical dry years will be the same as that applied to the American River parvice area.

(a) Deficiencies during critical dry years will be imposed on all water purchased by the Agency from the Central Valley Project but only on the agricultural portion of the water taken by the Agency without charge under its water permits to be obtained by it from the State Water Rights Board.

(f) Water the Agency will receive without charge can be used by it for either municipal, industrial or egricultural purposes upon demonstration of the such use made of these waters.

(g) The Agency will pay for Cantral Valley Project water a basic charge of \$1.50 per acre-foot for irrigation water and \$9.00 per sorefoot for municipal and industrial water, and in addition a surcharge,

if the Auburn Dam and Reservoir has been constructed by the Pederal Government, of the following emounts:

1992-1997 -- \$ 5,000 per year 1997-2002 -- \$10,000 per year 2002-2007 -- \$30,000 per year 2007-2011 -- \$45,000 per year

(b) The Agency may divert water under the schedule est forth under (a) above either from the American River prior to the construction of Auburn Reservoir or from Auburn Reservoir after its suthorization and construction.

(1) Water to be purchased from the Central Valley Project under Pederal Reclamation law will be for a period of 40 years with option to renew.

(j) Acceptance by your Agency of a normal water surface elevation of the proposed Auburn Reservoir of 934.5 feet and willingness of your Agency to construct and operate the American Ber features of your plan to recognize this elevation.

Approval of terms of the agreement and execution of the agreement with these terms included is done with the understanding that your Agency will withdraw its protest to water right permit requests by the United States for Auburn Reservoir and withdrawal of protests by the United States to permits requested by the Agency for its Middle Pork American River project, which permits would be consistent with the terms of the Agreement.

A formal indication of your willingness to include the above items into an agreement with the United States, and your assurance that the Agency will withdraw its protest to requests by the United States for permits for Auburn Reservoir, will be apprecisted.

MARCH 13TH 1962

The Placer County Water Agency met in regular session Tuesday, March 13, 1962, at 2:00 p. m. with all members present, Chairman Frank J. Paoli presiding; Elynor Freeman, Clerk. Also present were John M. Bernard, County Executive, am Stanley Kronick of the law firm of Kronick, Moskovitz and Vanderlaan, attorneys for the Agency. MINUTES

Motion was made by Briner, seconded by Radovich, all members voting aye, that the minutes of February 13, 1962, and the minutes of the special meeting of January 30, 1962, be approved as submitted.

WATER APPLICATIONS - Report Received on Subcommittee Hearing Requests for Dispositions of State Applications by Placer County Water Agency and Carmichael Irrigation District

Mr. Kronick read a memorandum to the California Water Commission from the members of the subcommittee hearing the Agency's request for release from priority on State Applications 7936 and 7937 in favor of the Agency's Applications 18084 through 18087. Kronick reported that the subcommittee recommends that no further action be taken until there has been an examination of the agreement with the Bureau. No action was taken.

BUREAU OF RECLAMATION - Resolution No. 62-3 Passed Accepting and Agreeing to the Basic Terms for an Agreement Between the Agency and the United States; Kronick, Moskovitz and Vanderlaan Instructed to Proceed with Draft of Formal Agreement

Stanley Kronick of the law firm of Kronick, Moskovitz and Vanderlaan read a letter from Mr. H. P. ^Dugan, Regional Director of the Bureau of Reclamation, Department of Interior, outlinging the basic terms for an agreement between the Agency and the ^United States.

Motion was made by Briner, seconded by Doyle, all members voting aye on roll call, that Resolution No. 62-3 be passed and adopted accepting and agreeing to the basic terms for an agreement between the Agency and the United States as set forth in a letter from Mr. Dugan to Frank J. ^Paoli, Chairman Placer County Water Agency, dated February 23, 1962, and directing the attorneys to proceed with preparation of a formal contract.

FEDERAL POWE COMMISSION - Resolution No. 62-4 Passed Authorizing Chairman to Sign and Verify Application for Federal Power Commission License for Middle Fork American River Project

Motion was made by Radovich, seconded by Anderson, all members voting aye on roll cal, that Resolution No. 62-4 be passed authorizing Frank J. Paoli as Chairman to sign and verify the application for Federal Power Commission license for the Middle Fork American River Project.

WATER RIGHTS - Reports Received on Pending Proceedings in California Supreme Court re Validity of Contract between Metropolitan Water District of Southern California and the State of California

Robert Radovich, Chairman of the Mountain Counties Water Resources Association, announced that the Association has adopted a resolution to support Contra Costa and San Joaquin County as a friend of Court in the mandamus proceedings in the California Supremem Court for the purpose of testing the validity of the contract between the Metropolitan Water District of Southern California and the State of California.

Receipt of resolutions from the Directors of the Plumas County Flood Control and Water Conservation District, the Supervisors of the County of Plumas, and the Northern California Counties Supervisors Association, Water Resources Committee concerning the pending suit were acknowledged.

The matter was deferred.

WATER RIGHTS - Meeting to be Arranged with El Dorado County Water Agency

John M. Bernard, County Executive, reported that El Dorado County Water Agency, is requesting a meeting with the Placer County Water Agency before the water rights hearings, and it was directed that the County Executive arrange a meeting with them and include the Georgetown Divide Utility District.

SALE OF POWER - PACIFIC GAS AND ELECTRIC - Chairman Authorized to Sign a Letter to P.G.& E. re Negotiations for Sale of Power

Motion was made by Doyle, seconded by Briner, all members voting aye, that the Chairman of the Board of Directors of the Placer County Water Agency be authorized to sign the letter to S. L. Sibley, Vice-President and General Manager of Pacific Gas and Electric, which was read before the Agency and that the letter be forwarded immediately. The letter asked that arrangements be made for a meeting to proceed with negotiations for the sale of power.

ROADS - Letter from Western States Trail Ride, Inc., Read and Filed

A letter from Wendell T.Robie of Western States Trail Organization was read in which it was requested that the trails in Placer County which will be affected by the Agency's project be given consideration.

A copy of a letter from U. S. Senator Clair Engle to Mr. Robie on this matter was acknowledged.

ROADS - Letters from Placer County Chamber of Commerce and Placer County Board of Realtors re Access Roads for the Agency Read and Filed

Letters from the Placer County Chamber of Commerce and Placer County Board of Realtors re access roads for the Agency were read and action deferred.

FINANCING - Receipt of Monies from Housing and Home Finance Agency Acknowledged

Motion was made by Radovich, seconded by Doyle, all members voting aye, that the receipt of a check from Housing and Home Finance Agency in the amount of \$277,425.00 be acknowledged. CLAIMS APPROVED

Motion was made by Radovich, seconded by Briner, all members voting aye, that the claim of McCreary-Koretsky Engineers in the amount of \$90, 315.00 be paid from the monies received from Housing and Home Finance Agency.

Motion was made by Doyle, seconded by Briner, all members voting aye, that the following claims be paid:
