Description of water conservation efforts	The Company utilizes company-owned and private deep wells to supply groundwater to portions of its Service Area. For 2015 the company delivered 3,403 acre-feet of groundwater from wells to lands within its boundaries to substitute for surface water. 1,740 acre-feet of this was part of a groundwater substitution transfer that the company participated in. The balance of 1,663 acre-feet should be added to the total amount of surface water diverted shown in this report. Use of groundwater is not only part of a conjunctive use program but also conserves water in that use of open ditches where water is subject to seepage and evaporation, is avoided. In addition landowners within the district have installed approximately 1700 acres of micro sprinkler and drip irrigation which provides additional conservation. It is estimated that conservation from well water use, micro sprinklers and drip irrigation provides a 40% savings from use. This calculates an estimated savings of 665 acre feet in 2015.

Additional Remarks

¿The Company utilizes company-owned and private deep wells to supply groundwater to portions of its Service Area. For 2015, the Company delivered 3,403 acre-feet of groundwater from its wells to lands within its boundaries to substitute for surface water. Out of this 3,403 AF of groundwater pumped, 1,740 acre-feet were pumped as part of the Company's 2015 groundwater substitution transfer to participating members of the State Water Project Contractors, Inc. The remaining 1,663 acre-feet pumped (3,403 minus 1,740) should be added to the total amount of surface water diverted shown in this report. In regard to items 8i through 8t, the Company holds a diversion agreement dated May 28, 1971 with the State of California acting by and through the DWR. The diversion agreement acknowledges the Company¿s riparian rights and License 7296 (Appl. ID 480). It defines the Company; s right to divert water annually in ¿Drought¿ (up to 10,000 acre-feet annually) and non-¿Drought¿ years (up to 14,000 acre-feet annually). 2015 was a ¿Drought¿ year under the terms of the diversion agreement. This report of licensee includes all surface water diversions by the Company during 2015, including under its License, riparian rights, and diversion agreement. On May 1, 2015 the State Water Resources Control Board curtailed all post-1914 water rights, including the Company¿s License 7296. After that date and until the curtailment was lifted, the Company¿s diversions were conducted under its riparian rights and diversion agreement. The Company¿s March 2015 diversions are considered diverted pursuant to its riparian water rights. The Company's April 2015 diversions, prior to curtailment, are considered diverted pursuant to the Company is License. For the balance of the year, the Company, s diversions constitute diversions under its riparian rights (up to 6,000 AF pursuant to the diversion agreement) and diversion agreement. 2016 is not a ¿Drought¿ year under the diversion agreement and the Company¿s projected diversions in accordance with the diversion agreement will be up to 14,000 acre-feet. In regard to items 8e through 8h, the Company petitioned the State Water Resources Control Board for temporary changes to its License to allow for the temporary transfer of surface

water via groundwater substitution. That petition was denied because the right to divert under the License was curtailed due to dry conditions. However, the transfer proceeded in accordance with the Company¿s diversion agreement and under DWR¿s State Water Project water rights. In regard to item 5, the Company holds riparian rights to the Feather River. These rights are recognized and quantified in the Company¿s diversion agreement.¿
